## **APPLYING IS EASY**

Grant proposals must contain all of the items listed below. Incomplete proposals will not be considered.

#### Your grant proposal must include:

- 1. Cover letter indicating project leader or person responsible for funds (include all contact information: address, telephone number and project leader email address).
- 2. Organizational overview (mission of organization, your programs and major activities).
- 3. General description of project (no more than three to five pages) that includes:
  - a. Problem statement (Why are you doing this project? What is the need within the community?)
  - b. Goals and objectives
  - c. Project activities
  - d. Target population (demographics)
  - e. Listing of other partners in the community (if applicable)
  - f. Estimation of project start and end dates
- 4. Project budget and amount requested.
  - a. Listing of other funding sources for the project (include financial commitment)
- 5. W-9 form with a tax ID number and 501c(3) certificate (if applicable).

- Provide a budget for the project, outlining what the funds will be sent on with as much detail as possible (you will not be required to purchase identified materials if alternatives are identified that complete the task).
